

MASTER TRUCK DRIVER *(focus on years with company/industry)*

Category Description:

The **Master Truck Driver** award recognizes our industry's top drivers who have compiled a career record of excellence through professionalism and service. The **Master Truck Driver** award is meant to recognize professional drivers who have proven a career of longevity and safety in the industry.

Eligibility Requirements:

In order to be nominated for the **MASTER TRUCK DRIVER** award, applicants must meet the following criteria & submit all requested documents listed below.

- Driver must be nominated, and employed, by an IMTA member company
- Driver must be a full-time driver, driving at least 11 of the past 12 months
- Driver must be employed by the company for at least 10 years
- Driver must have driven at least 10 years, or 1,000,000 miles, without a preventable accident. (Years do not need to be concurrent.)
- Driver must have no moving violations or roadside inspection violations in the last 3 years.
- Driver must be able to attend awards banquet the evening of Thursday, September 5, in Cedar Rapids, IA at the DoubleTree – Downtown Cedar Rapids

Required Documents:

- Completed nomination form
- MVR

Prize Opportunities & Recognition Details:

Awards will be presented in conjunction with the IMTA's Management Conference at the IMTA Awards Gala on the evening of Thursday, September 5, in Cedar Rapids, IA at the DoubleTree – Downtown Cedar Rapids.

The individuals selected to be recognized as a **MASTER TRUCK DRIVER** will each receive **\$500 cash and additional awards hardware**. One overall winner will be selected from the nominees and named the overall **Master Truck Driver of the Year**. This individual will receive an additional **\$1,500 cash and a commemorative gift**.

IMTA Communications Process:

- 1) **Receipt of Nomination Form** --- an IMTA representative will email the nominator to confirm the completed nomination form & all accompanying documents have been received. Should any information be missing, the IMTA representative will inform the nominator at this time that the nomination form is not considered eligible & all missing items must be submitted by **FRIDAY, JULY 12, 2024, at 5:00 PM.**
- 2) **Email Notification to Nominator** --- an IMTA representative will email the nominator to inform them if the submitted nominee will be recognized at the IMTA Awards Gala. At this time, the nominator will also be informed of what is being mailed to the home address of the nominee. Estimated timeframe for this process is to conclude 2-weeks post deadline date of **FRIDAY, JULY 12, 2024, at 5:00 PM.**
- 3) **Mailing to Nominee's Home Address** --- an IMTA representative will mail a formal letter to the nominee to inform them of their nomination and if they will be recognized at the IMTA Awards Gala. Estimated timeframe for this process is to conclude 2-weeks post deadline date of **FRIDAY, JULY 12, 2024, at 5:00 PM.**
