A good maintenance program coupled with dedicated individuals to carry out the mission of the maintenance department is the perfect combination to a winning solution.

Eligibility Requirements:

To be nominated for the **FLEET MAINTENANCE PROGRAM** award, applicants must meet the following criteria & submit all requested documents listed below.

- Fleet must be an IMTA member company
- Fleet must have a minimum of one company maintenance facility
- Fleet must employ a minimum of one employee who performs fleet maintenance in a company facility
- Fleet should have preventative & repair maintenance processes in place & be willing to share details of those processes (no specific protected details are required)
- Fleet should have a proven record of a strong maintenance history through roadside inspection data, vendor recommendations & assistance, low number of breakdowns, etc.
- Fleet representative(s) must be able to attend the awards banquet on the evening of Thursday, September 24, in Coralville, IA at the Hyatt Regency hotel and conference center

Required Documents:

- Completed nomination form
- Documentation to support nomination, if available

Prize Opportunities & Recognition Details:

- Awards will be presented in conjunction with the IMTA's Management Conference at the IMTA Awards Gala on the evening of Thursday, September 24, in Coralville, IA at the Hyatt Regency hotel and conference center.
- The fleets selected to be recognized as **FLEET MAINTENANCE PROGRAM** finalists will each receive an **award** to commemorate the program's nomination. One overall winner will be selected from the nominees and named the overall **Fleet Maintenance Program of the Year**. This program will receive **\$1,000 cash to spend on the department and a commemorative banner.**

IMTA Communications Process:

- 1) **Receipt of Nomination Form** --- an IMTA representative will email the nominator to confirm the completed nomination form & all accompanying documents have been received. Should any information be missing, the IMTA representative will inform the nominator at this time that the nomination form is not considered eligible & all missing items must be submitted by **THURSDAY, AUGUST 6, 2026, at 5:00 PM**
- 2) **Email Notification to Nominator** --- an IMTA representative will email the nominator to inform them if the submitted nominee will be recognized at the IMTA Awards Gala. Estimated timeframe for this process is to conclude 2-weeks post deadline date of **THURSDAY, AUGUST 6, 2026, at 5:00 PM**
