

PROFESSIONAL DISPATCHER

Category Description:

The dispatcher is at the heart of every trucking operation and each day the pulse of the operation rests in the dispatcher's expertise, demeanor, and ability to manage a lot of things and people at one time. The dispatcher is critically important to the success of the operation.

Eligibility Requirements:

In order to be nominated for the **PROFESSIONAL DISPATCHER** award, applicants must meet the following criteria & submit all requested documents listed below.

- Professional Dispatcher must be nominated, and employed, by an IMTA member company
- Only one Professional Dispatcher per IMTA member company may be nominated
- Professional Dispatcher must be a full-time employee of company
- Professional Dispatcher must be employed by the company for at least 3 years
- Professional Dispatcher <u>must be able to attend</u> awards banquet the evening of Thursday, September 11, in Des Moines, IA at the Des Moines Marriott Downtown.

Prize Opportunities & Recognition Details:

Awards will be presented in conjunction with the IMTA's Management Conference at the IMTA Awards Gala on the evening of Thursday, September 11, in Des Moines, IA at the Des Moines Marriott Downtown.

The individuals selected to be recognized as a **PROFESSIONAL DISPATCHER** will each receive **\$250** cash and additional awards hardware. One overall winner will be selected from the nominees and named the overall **Professional Dispatcher of the Year**. This individual will receive an additional **\$1,000** cash and a commemorative gift.

IMTA Communications Process:

- Receipt of Nomination Form --- an IMTA representative will email the nominator to confirm the completed nomination form & all accompanying documents have been received. Should any information be missing, the IMTA representative will inform the nominator at this time that the nomination form is not considered eligible & all missing items must be submitted by THURSDAY, JULY 31, 2025, at 5:00 PM.
- 2) Email Notification to Nominator --- an IMTA representative will email the nominator to inform them if the submitted nominee will be recognized at the IMTA Awards Gala. At this time, the nominator will also be informed of what is being mailed to the home address of the nominee. Estimated timeframe for this process is to conclude 2-weeks post deadline date of THURSDAY, JULY 31, 2025, at 5:00 PM.
- 3) Mailing to Nominee's Home Address --- an IMTA representative will mail a formal letter to the nominee to inform them of their nomination and if they will be recognized at the IMTA Awards Gala. Estimated timeframe for this process is to conclude 2-weeks post deadline date of THURSDAY, JULY 31, 2025, at 5:00 PM.
